#### 1 Introduction

This report is the result of Activity 2.1 'Collecting best practices in strategic planning' of the project 'Technical Assistance to the Strengthening of Strategic Planning Capacities in selected Ministries in Lebanon' funded by the European Union and managed by the Office of the Minister of State for Administrative Reform (OMSAR).

Strategic planning is part of the planning and control cycle. This cycle consists of strategic planning (long term or mid-term: 3-5 years) operational planning (short term: one year) and reporting on progress as well as feed-back on the realism of the strategic and operational plans.

In line with this thinking, the report sets out to make accessible a collection of strategic plans and other planning and control documents such as progress reports that may be considered to reflect international best practices.

The categories of documents are

- Strategic plans
- Operational Plans
- Reports

For each of these categories of documents, with the exception of the category 'miscellaneous', criteria were formulated in line with the manual for strategic planning developed by the project.

The links to the documents are shown and the reports are scored against the criteria mentioned. In the case of strategic reports a table has been added which criteria are met and which not, due to the quantity of criteria (eleven).

Purpose of this project activity is make accessible international best practices to government staff interested or involved in strategic planning, and to the general public. Therefore the document ends with recommendations aiming at development of the collection and its accessibility.

#### 2 Strategic plans

In order to assess whether the strategic plans may be considered valuable study material or reference for comparison, the strategic plans have been scored against a series of criteria. These criteria come from the Manual for Strategic Planning developed by OMSAR in the framework of the EU funded project "Technical Assistance to the Strengthening of Strategic Planning Capacities in Selected Ministries in Lebanon", that was carried out starting from October 2014.

These criteria are formal in nature. The authors of this report cannot judge on the content of the strategic plans, nor can they assess whether the plans are realistic, financially or form an organizational or political point of view.

The formal criteria are:

1. The availability of an analysis of the current situation of the organisation or the sector it works in.

- 2. The availability of quantitative date underpinning the analysis and that may serve as base line assessment
- 3. The formulation of a mission statement
- 4. The formulation of a vision statement
- 5. The formulation of a values statement
- 6. The formulation of strategic goals
- 7. The identification of specific objectives that lead to reaching the strategic goals
- 8. The identification of major activities/projects/courses of action that lead to reaching these specific objectives
- 9. The presence of a system for monitoring the success of the strategic plan (including performance indicators, benchmarks etc)
- 10. The availability of operational plans that detail the major activities/ projects/courses of action that lead to reaching these specific objectives
- 11. The availability of periodic reporting on the progress of the strategic plan, and the operational plans.

The strategic plans referred to in this report are all in English. Although strategic plans have been found in other languages, they have not been included in this collection. With a few exceptions they all come from and are made for public or semi-public entities.

Hereunder the list is given of the strategic plans considered to be of sufficient quality in order to be part of this collection and finally a table with the score as given by the author.

#### 4 - Examples of reports related to strategic plans

Other than with regard to strategic plans the internet research did not yield very many examples of periodical reports related to earlier strategic or operational plans. The reason for this may be that public institutions and private companies consider strategic plans as a marketing and publicity instrument whereas the other documents tend to be seen as internal document. Even examples were found where the strategic plan was written in English, and the subsequent reports in the local language, in this case Spanish.

The few examples found were scored against the following criteria:

- a. Do they compare the achievement with a preceding plan (strategic or operational)?
- b. Do they in any way enable the reader to assess progress by showing changes in indicators or otherwise?
